WHEREAS, the Clay County Council desires to amend and replace the existing language of Paragraph 1 of said Ordinance No. 11-2007.

BE IT, THEREFORE, ORDAINED, BY THE CLAY COUNTY COUNCIL:

1. Ordinance No. 11-2007 and Ordinance No. 03-2005 are hereby amended and revised by striking the existing language of Paragraph 5 of Ordinance No. 03-2005, as modified by Ordinance No. 11-2007, and substituting the following:

" 5. In consideration of providing the above-referenced services to those seeking an abatement, the Redevelopment Commission may charge an abatement application filing fee sufficient to defray its reasonable legal expenses and fees in retaining counsel to prepare the necessary documentation in consultation with the applicant."

2. All other existing language of Ordinance No. 03-2005 shall remain in full force and effect.

ORDINANCE NUMBER 6-2015 ORDINANCE ESTABLISHING A DEDICATED FUND FOR COMPLIANCE WITH FINANCIAL ASSURANCE FOR UNDERGROUND STORAGE TANKS

Larry Moss read in full the following:

WHEREAS, for compliance with Indiana Code Section 13-23-8, and the Indiana Administrative Code Sections 329 IAC 9-8-4, 329 IAC 9-8-11 and 329 IAC 9-8-17, and for compliance with the Indiana Department of Environmental Management, it is necessary to establish a dedicated fund for Excess Liability Trust Fund Through Local Government Mechanisms;

NOW, THEREFORE, be it ordained as follows:

- A. A dedicated fund/account for Compliance with Financial Assurance for Underground Storage Tanks is hereby established;
- B. Such fund/account shall not be commingled with other funds or otherwise be used in normal operations;
- C. Such fund/account is established to pay for taking corrective actions and for compensating third parties for bodily injury and property damage caused by accidental releases arising from the operation of petroleum underground storage tanks owned by Clay County; and
- D. The sum of \$30,000.00 shall be held in such fund.

This Ordinance supersedes any prior Ordinance contrary hereto.
